Background Information:

In November 2005, the CRA Board formally adopted the Strategic Finance Plan for the Downtown/City Center CRA District. In June 2006, the CRA Board formally adopted nine (9) incentive programs, many targeting the Historic Northwest neighborhood. One such program, the

Facade and Interior and Exterior Improvement Grant Program, is intended to encourage property owners to upgrade the interior and exterior of existing buildings.

The CRA received an application from WeSecondChance LLC for a grant under the Interior and Exterior Facade Grant Program for the property located at 800 N. Sapodilla Avenue in the Historic Northwest Target Area. This is a viable project and meets the criteria set forth in the Facade Grant Program. The application submitted is for qualifying exterior renovations to an existing structure. The renovations include but are not limited to, repairing and re-stuccoing the exterior and installation of new signage, doors, and windows for a total project cost of \$122,515. In accordance with the Interior and Exterior Facade Program, the applicant is required to contribute 20% of the construction cost, and the Agency will contribute 80%, not to exceed \$75,000.

Resolution No. 24-62 approves a grant to WeSecondChance LLC in the amount of \$75,000 for qualifying improvements to the property located at 800 N Sapodilla.

Background Information:

The Community Redevelopment Agency obtained the property located at 719 N. Sapodilla in September 2016 to improve a heavily blighted area.

While the CRA is currently following the Board's direction to rehabilitate the structure, the local business market has shown interest in the property. Due to market trends, staff recommends advertising the disposition of the property in order to entertain formal proposals for the sale and activation of the property for a Health-Conscious Dining use.

All proposals will be brought to the Board with a recommendation to proceed with an offer. This action is consistent with the goals and obligations of CRA's redevelopment plan and strategic finance plan.

Resolution No. 24-63 authorizes the disposition of 719 N. Sapodilla Avenue and the publication of a notice to accept competing business proposals.

Background Information:

In August 2017, via Resolution No. 17-42, the CRA Board approved an incentive program named the Contributing Structure Rehabilitation Grant Program. The intent of this incentive program is to support and preserve

residential buildings in the Northwest neighborhood that contribute historical significance by location, design, setting, materials, workmanship, feeling, and association. Examples of approved renovations through this program include painting the building, installation of new awnings, new doors/windows, landscaping, roofing, and pavers.

Joshua Hilleman submitted a Contributing Structure Rehabilitation Grant Program application requesting \$75,000 for the renovation of an existing two-story residential structure of historical significance located in the northwest neighborhood. The proposal is to complete the following improvements:

- Roof and balcony repair
- Re-stuccoing and painting of home
- · Installation of front and rear gate
- Installation of paver driveway, walkway, and entranceway

The proposed improvements have been reviewed and approved by the Historic Preservation Board.

Resolution No. 24-64 approves a grant to Joshua Hilleman in an amount not to exceed \$75,000 under the Contributing Structure Rehabilitation Grant Program and authorizes the CRA Chair to execute a grant agreement. The proposed grant supports the Historic Northwest Target Area Goal 1: Protect the neighborhood's historic fabric.
